- Soil Vapor Extraction (SVE)
- Nano- and Phyto-Remediation
- 71,000ppb to 330ppb within 16 days
- Vegetation growth in 33 days

WMD Environmental Remediation

- CBRNE Veterans Working Roadside Remediation
- Began Work with Environmental Chemists to Explore Soil Shredding and Tactical Placement of Decontaminants
- Process Currently Used Around the World
- Requires Hazard Identification, Scientific Reachback,
 Heavy Equipment and HAZMAT Technicians

Clandestine Laboratory Site Safety Certification

- Filled a Need for Detailed Awareness, Operations and Technician Level Training
- Designed for Hostile Threat Mitigation and CBRNE Response/Incident Command Forces
- Course Material Written and Approved Based on Real-World Response Experience

CBRNE Emergency Response Teams

- First Began Work Under DHS-USCBP Contract as WTD
- Two Checkpoints Grew Into Multiple Sectors with Dozens of Land Bridges over 1,300 miles
- CBRNE Technicians Required to Respond, Identify, Extract, Provide Evidentiary Sampling and Prosecutorial Reporting
- Assigned to Ebola Governor Task Forces in Multiple States
